Privacy & Data protection Policy

This privacy & Data protection Policy describes the ways in which Art-Distribution EU Ltd. (**The Wholesaler**) collects, stores, and processes personal data collected from registered users (**Users**) of www.art-distribution.eu

The Administrator of this data is Art-Distribution EU Spzoo (Ltd.), Polish Company Registry (KRS) number 0000100271 in accordance with The General Data Protection Regulation (EU Directive 2016/679 of April 27, 2016, commonly known as GDPR) applicable from May 25th 2018 in the European Union. Building on current data protection laws, GDPR gives every business a new set of obligations and every consumer strengthened rights regarding their data. .

What data do we collect?

The personal data which are required to open an account are:

- Company name and address (personal data only if Company is a sole trader or personal business)
- First name, last name
- Any address other than Company's address designated by user as delivery address
- e-mail
- telephone number

How will we use this data?

For how long will your data be stored?

All transaction data will be stored for financial & tax reporting requirements for 6 years, after which time they will be deleted. User accounts which are inactive for more than two years will be deleted. At user's request, all data will be anonymised or deleted within 7 days (see below)
